I. The inquiry is connected with the implementation of a R&D commercial project, co-financed from the government budget by the polish Medical Research Agency (Agencja Badań Medycznych).

II. SUBJECT OF CONTRACT: Size parts for IMA-SAFE C40R with setting up at Customer's plant

Device characteristics:

Size parts for product feeding

- Feeding size for round biconvex tablets for ALU/ALU.
- Identification of the machine change parts in direct contact with the product including the surface area calculation and the surface roughness

Size parts for blister

- Partial additional size parts for ALU-ALU for round biconvex tablets
- ALU/ALU blisters cutting positioning
- Size plate for pinhole detection of the ALU/ALU blisters

Setting up at Customer's plant

Blister material

- **Forming Material:** ALU/ALU 0,14mm
- **Lidding Material:** ALU 0,02mm

Blister Dimensions (mm): Width x Length x Thickness: 47×110×6

Number of Tablets in blister: ≥7

Tablet: $\phi 9R10$ (Thickness: 5,0-6,5mm)

Additional requirements

- The machine operating speed specified in the offer is confirmed before delivery during testing on the IMA-SAFE C40R
- Blister machine assembly and setting instructions available for the supplied equipment

IV. ORDER COMPLETION DEADLINE

- Order completion date: up to 4 months from the date of placing the order.

V. TERMS OF PARTICIPATION IN THE PROCEEDINGS

- Assured warranty and post-warranty service in Poland

VI. DESCRIPTION OF THE PRICE CALCULATION

- The price should be calculated in net and gross values and entered in the bid form.
- Prices expressed in a currency other than PLN will be converted into PLN according to the average exchange rate of the National Bank of Poland as of the date of opening the proceedings.
- The price should include all costs related to the execution of the order.

VII. OFFER EVALUATION CRITERIA

- When evaluating tenders, the Ordering Party will be guided by the following criteria:
 - Price - weight 90%
 - Order completion date - weight 10%

The point evaluation of the offer will be made in accordance with the following formula:

$$O_P = P_C + P_T$$

where:

O_P - point evaluation of the offer

P_C - the number of points obtained under the "Price" criterion

P_T - the number of points obtained under the criterion "Order completion date"

C_B - net price of the examined offer

- The number of points (P_C) in the "Price" criterion will be calculated according to the formula:

$$P_C = \frac{C_N}{C_B} * 90$$

- order completion time less than 3,5 months - 10 points
- order completion time from 3,5 to 4 months - 5 points



➤ order completion time over 4 months - 0 points

- The tender with the highest number of points will be considered the most advantageous. The offer can get a maximum of 100 points. Calculations will be made with an accuracy of two decimal places.

VIII. DATE AND FORM OF SUBMISSION OF OFFERS

- Bids must be submitted by the deadline of August 26, 2025.

IX. OTHER ESSENTIAL TERMS OF THE ORDER

Payment terms: transfer, VAT invoice, payment term 14 days.

Contractual penalties: in case the bidder fails to complete the order within the declared period, the contractual penalty is up to 5% of the order value.
